As a result of the state of emergency declared by the President of the United States, Governor of Kentucky, and Mayor of the City of Frankfort due to the global COVID-19 pandemic, and in accordance with recommended and mandated precautions related thereto and Kentucky Opinion of the Attorney General 20-05, the following Meeting Notice is issued:

I, Layne Wilkerson, hereby call a Special Meeting of the Frankfort Board of Commissioners for Tuesday, March 30, 2021, at 2:00 p.m., in the Frankfort/Franklin County Emergency Operations Center, 300 West Second Street. The meeting will recess and reconvene on Wednesday, March 31 at 2:00 p.m. and Thursday, April 1 at 1:00 p.m. The purpose of this meeting is to interview and discuss candidates for the position of City Manager. A portion of this meeting may be closed per KRS 61.810 (1)(f), Personnel, to interview and discuss candidates which might lead to an appointment to the City Manager position. Action may be taken in open session.

Per KRS 61.826, this meeting is a video teleconference meeting. One or more members of the Board of Commissioners will participate via Skype or a similar video teleconferencing system. Per KY Attorney General Opinion 20-05, **public attendance will not be permitted** at this meeting because, due to the highly contagious nature of COVID-19, it is not feasible for the City to provide a central physical location for public viewing.
