The purpose of this note, and the many that will follow, is to provide you with recent and immediate future activity concerning the Second Street TIGER grant project.

- The first of numerous utility relocation and replacement projects, which will occur over the next several years, begins Monday, April 1st. This project will involve water line replacement by the Frankfort Electric and Water Plant Board (FEWPB) between East Broadway and Martin Luther King, Jr. Boulevard. FEWPB plans to place message boards at each end of the project on Monday, March 25th to provide motorists advance notice of the impending work. Two lanes of traffic, one in each direction, will be maintained.
- The three days of stakeholder meetings have been scheduled. The purpose of these meetings is to provide individuals or small groups the opportunity to learn more about the project from the Strand Associates team and to listen to comments and concerns from a wide variety of interests. As with any project of this scope and complexity, there are sometimes competing factors affecting the design and implementation. It is our goal to find a reasonable balance between these competing factors. Here are the details for these stakeholder meetings:
 - Thursday, April 4th beginning at 9:00 a.m. in the City Hall Conference Room - - The landscape architect/streetscape sub-consultant (Human Nature of Cincinnati) along with other Strand Associates team members will be available on this date. If you have an interest in the streetscape aspect of this project, please plan to attend sometime on this date.
 - Tuesday, April 9th beginning at 9:00 a.m. in the City Hall Conference Room
 - Friday, April 12th beginning at 9:00 a.m. in the City Hall Conference Room

We have set aside 30-minute time slots that will run from 9:00 a.m. each of these three mornings with the last time slot beginning at 3:30 p.m. each day. Please e-mail me and schedule a day and time for up to a 30-minute session to come to City Hall and learn more about the project and share your ideas and concerns for this project.

- We continue to develop a project stakeholder list with contact information so that we may keep interested parties informed of project status. We are also developing a separate property owner list with contact information.

For those of you who did not receive the previous update note, attached for your information is a project map and the overall project schedule. Please understand that the attached project schedule is the schedule included in the USDOT/KYTC and KYTC/City TIGER grant agreements. As with many complex and lengthy projects such as the Second Street TIGER grant project, there are numerous factors that may alter the schedule as the project progresses. It is the City's expressed intent to follow the attached schedule as closely as possible.
