“AN ORDINANCE AMENDING CITY OF FRANKFORT CODE OF ORDINANCES SECTIONS 37.31 AND 37.32 RELATED TO OFFICER AND EMPLOYEE PAY STRUCTURE, CLASSIFICATION AND COMPENSATION, AND DELETING SECTION 40.57 RELATED TO AN EMERGENCY PREPAREDNESS COORDINATOR”. Summary: This ordinance 1) amends City of Frankfort Code of Ordinances Section 37.31 and 37.32 to update “COF Salary Schedule,” incorporated by reference, to include the full-time position of Emergency Management Director; and 2) Deletes Section 40.57, Emergency Preparedness Coordinator, in its entirety as this position no longer exists.
