Staff Reports

Rebecca Hall, Community Relations/Grants Manager, spoke about ARPA Funds and KLC has encouraged the City to take the standard allowance. This will be an item on the May Regular Meeting agenda.

Kenny Hogsten, Sewer Department Director, updated the Board of Commissioners on the Consent Judgement Decree which was entered into in 2007 and the EPA has dropped consent with the State. The Sewer Department will be meeting with the Department of Water to see how to move forward.

Discussion Items

Proposed Telecom Ordinance

Laura Ross, City Solicitor, spoke about the proposed Telecom Ordinance which will allow companies to do fiber work in the right of way. The City of Frankfort has never had a telecom ordinance; however, the ordinance puts the City in control for notifications, public notices, plans, permitting and fees. Following additional discussion, the Board of Commissioners directed staff to place on the May 23 Regular Meeting agenda for a first reading.

Proposed Solid Waste Ordinance Changes Update

Byron Roberts, Solid Waste Superintendent, reviewed the changes that Public Works would like to see in the Solid Waste Ordinance update such as carts, fees, scheduled free weeks and more. The Board of Commissioners agreed to place this item on the May 23 Regular Meeting agenda for a first reading.

Johanson Group Compensation Study
